Resolved, by the Board of Trustees, that it hereby authorizes the submission of a one-year grant proposal to receive funding for FY 2024 for Multi-Disciplinary Teams (MDT) to provide trauma-informed culturally competent services to people with disabilities who have been victims of crime. In the event of loss or misuse of the grant funds, the MHMR Board of Trustees assures that the funds will be returned to the Office of the Governor in full.

Approval to Submit a Grant Application to the Criminal Justice Division Office of the Governor for Trauma-Informed Mental Health Services for First Responders Under the Mental Health Law Liaison Resilience Project

Resolved, by the Board of Trustees, that it is in the best interest of the citizens of Tarrant County, to provide trauma-informed mental health services to first responders who, due to the nature of their job, are highly likely to witness traumatic events.

Resolved, by the Board of Trustees, that it hereby authorizes the submission of a one-year grant continuation proposal to apply for funding for FY 2024 for trauma-informed mental health services for first responders under the Mental Health Law Liaison Resilience Project. In the event of loss or misuse of the grant funds, the MHMR Board of Trustees assures that the funds will be returned to the Office of the Governor in full.

It is further resolved, the Board of Trustees designates Susan Garnett, CEO, as the grantee's authorized official. The authorized official is given the power to apply for, accept, reject, alter or terminate the grant on behalf of MHMR.

- COVID-19 Update Grace White shared COVID-19 numbers for the agency. Ms. White mentioned low community spread but high transmission level currently for Tarrant County.
- Legislative Update Ms. Garnett shared that Tarrant County has requested development of a Mental Health Facility for competency restoration. Ms. Garnett shared that wages and inflation are being discussed in Austin.
- Super Doc Texas Monthly 2022 Ms. Garnett shared that Dr. Carol Nati was named a Super Doc by Texas Monthly, as voted on by her peers.
- Employee Update Appreciation from employees was shared for longevity/retention payments.
- Holiday Recap Catherine Carlton shared highlights from several holiday events for the people we serve.
