April Financials

Mr. Bovos reviewed the April Financials and highlighted both the performance in the General Fund as well as within Behavioral Health, tying together our ability to generate revenue through the employees that are patient facing. While departments are focused on hiring needed staff and completing the required administrative duties required to bill for services, Finance is focused on receivable collection and management.

CEO Report

- Revenue/Expenditures Susan Garnett shared three expenditure updates for the last month.
 - i. Tarrant County Hospital District JPS for psychiatric beds, for funding that is available. Additional 803 bed days from them.
 - ii. Primary Care services at Tarrant County Mental Health Jail Diversion Center
 - iii. Family Connects International Finalized contract for implementation of Family Connects along with getting certified.
- 1115 Transition (Directed Payment Program) Update Ms. Garnett shared updated during financial report. There are two buckets, Directed Payment Program, payment made in additional to base Medicaid payment. Charity Cares Program, acquire funding for uninsured people. Mr. Bovos has spent time identifying strategies to capture funds and including in cost report.
- Legislative Update: Regular session ended yesterday, there is a special session taking place right now.
 - i. There will be new money in Mental Health services, designed for specific purposes.
 - ii. IDD workforce minimum wage for direct care workers, decreased from expected amount of \$15 to \$10.60 an hour.
 - iii. Did not receive funding proposal for pilot for moving IDD services into managed care organizations, without pilot can not be moved over.
 - iv. Additional funding in ECI, not sure how money will roll out.
 - v. DFPS will be moved over to HHSC structure
 - vi. Mothers who are on Medicaid, currently only had access to Medicaid for only two months postpartum, will now have Medicaid for 12 months postpartum.
 - vii. Jail Based Competency Program Grant for more funding to complete at local government level.
